

RESOLUTION No. 2005-129-306

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDED A BID IN THE AMOUNT OF FIFTY THOUSAND, EIGHTY DOLLARS (\$50,080.00) TO TROPIC FENCE, INC., FOR THE INSTALLATION OF A FENCE AT THE PUBLIC WORKS AND PARKS AND RECREATION MAIN OPERATIONS CENTER; AUTHORIZING THE ISSUANCE OF A PURCHASE ORDER; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City's Public Works and Parks and Recreation Departments are using an old inspection station located at 3000 N.W. 176th Street ("Station") for storage of equipment and vehicles, and

WHEREAS, the fencing that is erected around the Station is in a state of disrepair and needs to be replaced, and

WHEREAS, City staff prepared specifications and advertised bid document #04-05-015(A) on September 1, 2005 ("Bid"), and

WHEREAS, three (3) responses were received to the Bid, and

WHEREAS, the responses to the Bid were evaluated for compliance with the specifications, performance and cost, and

WHEREAS, the apparent low bidder was Tropic Fence, Inc., and

WHEREAS, Tropic Fence, Inc. is able to perform the services requested, and

WHEREAS, the City Manager recommends that the Bid be awarded to Tropic Fence, Inc., in an amount not to exceed Fifty Thousand, Eighty (\$50,080.00) Dollars, and

WHEREAS, funding for this request is available in the Transportation Budget,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AWARD OF BID: The City Council for the City of Miami Gardens hereby awards Bid No. 04-05-015(A) to Tropic Fence, Inc., in an amount not to exceed Fifty Thousand, Eighty (\$50,080.00) Dollars and authorizes the City Manager to issue a purchase order for this purchase.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
