A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE RENEWAL OF AN EXISTING AGREEMENT WITH AIR B SCHOOL BUS TRANSPORTATION, INC.; AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS ON AN AS-NEEDED BASIS, NOT TO EXCEED THE BUDGETED AMOUNT; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on December 14, 2005, the City Council authorized the award of ITB#05-06-001 Bus Transportation Services and authorized the City Manager to issue purchase orders to Air B School Bus Transportation, Inc. ("Air B"), and

WHEREAS, the Contract with AIR B will expire on December 14, 2007, and

WHEREAS, the Contract can be extended for an additional four years on an annual basis, pending budget allocation and the discretion of the City, and

WHEREAS, bus services are required for after school programs and summer/holiday camp programs, and

WHEREAS, City staff is pleased with the overall performance of AIR B and is recommending renewal of the existing Contract,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Council of the City of Miami Gardens hereby authorizes a four year extension to that certain agreement between the City and AIR B School Bus Transportation, Inc., and further authorizes the City Manager to issue

purchase orders on an as needed basis, not to exceed the budgeted amount of \$170,000.00.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.

Staff Summary
