A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDING A BID TO HARRISON UNIFORM COMPANY FOR THE PURCHASE OF PUBLIC SAFETY UNIFORMS; AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS ON AN AS NEEDED BASIS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City is in the process of ordering supplies for its Police Department, and

WHEREAS, it is necessary, for the City to order uniforms for both sworn Police Officers and Community Service Aids, and

WHEREAS, a bid was advertised on April 11, 2007, to 213 suppliers of police uniforms, and

WHEREAS, three bids were received and publicly read, and

WHEREAS, the bids that were received were evaluated for compliance with the specifications and the company's ability to provide the uniforms as required, and

WHEREAS, although the apparent low bidder for Group A Uniforms and Group F Uniforms is Superior Uniform Group, Inc., after examining the uniform samples submitted, staff has determined that the quality of the uniforms that would be provided by Superior Uniform Group, Inc., is inferior to that of Harrison Uniform Company located in Miami, Florida, and

WHEREAS, City staff is recommending, that the City Council award a bid to Harrison Uniform Company for the purchase of the uniforms as outlined on Exhibit "A" attached hereto, and

WHEREAS, funding for this expenditure is available in the Police Department budget, and the allocated budget for uniforms for 2006 – 2007 is \$299,000.00,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Council of the City of Miami Gardens, Florida, hereby awards a bid to Harrison Uniform Company for Group A Uniforms, Group B Supplement Uniforms, Group C Outerwear, Group E Uniform Accessories and Group F Community Service Aid Uniforms in an amount not to exceed the budgeted amount of \$299,000.00. Furthermore, the City Council authorizes the City Manager to issue Purchase Orders to Harrison Uniform Company on an as needed basis.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDED A BID TO HARRISON UNIFORM COMPANY FOR THE PURCHASE OF PUBLIC SAFETY UNIFORMS; AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS ON AN AS NEEDED BASIS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

Staff Summary

The Police Department sworn officers and community service aids are required to wear uniforms. The City will supply six sets of uniforms for patrol officers and five sets of uniforms for all officers per year. Each officer will also receive dress uniform, hat, pair of shoes, jacket, uniform accessories and BDV.

The Command staff reviewed and sampled different uniform styles, materials and manufacturers to determine which style and material best suited the needs of the City's officers. Staff prepared specifications based on the Command staff's determination for a term contract to purchase public safety uniforms for an initial period of one year with option to renew annually subject to appropriation of funds not to exceed a maximum of three years. The bid was advertised on April 11, 2007. A broadcast notice was issued to 213 suppliers. A mandatory pre-bid was held on April 17, 2007, three companies attended. Uniform samples were required to be submitted with the bids which were opened on April 26, 2007. Three bids were received and publicity read. (see attached bid tabulation)

The uniform samples were evaluated for compliance with the specifications and the companies' ability to provide the uniforms as required. The apparent low bidder, for

Group A Uniforms; Group F CSA Uniforms is Superior Uniform Group, Inc. located in Seminole, Florida, however, after examining the uniform samples submitted, staff determined that the quality of material did not meet specifications. Harrison Uniform Company, located in Miami, Florida is the second apparent low bidder. Uniform samples provided by Harrison Uniforms were determined to meet specifications. Staff also evaluated footwear; Law Enforcement Supply Company, Inc. located in Miami, Florida is the apparent low bidder for Group D Footwear. It is anticipated that expenditures for foot wear will not exceed the City Manager's spending authority and therefore is not included in this agenda item for your approval.

Staff recommends awarding the purchase of public safety uniforms to Harrison Uniform Company for Group A Uniforms, Group B Supplement Uniforms, Group C Outwear, Group E Uniform Accessories and Group F CSA Uniforms Supply Company and authorizing the City Manager to issue purchase orders as needed. Funding for this expenditure is available in the Police Department Budget. The allocated budget for uniforms is \$299,000.
