

RESOLUTION NO. 2004-100-151

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY CLERK TO EXECUTE AND ATTEST, RESPECTIVELY, A CONTRACT WITH SALMAN MAINTENANCE SERVICE, INC. D/B/A U.S. LAWNS OF SOUTH DADE FOR MISCELLANEOUS PUBLIC WORKS SERVICES BY PIGGYBACKING ON THAT CERTAIN AGREEMENT BETWEEN SALMAN MAINTENANCE SERVICE, INC. D/B/A U.S. LAWNS OF SOUTH DADE AND THE TOWN OF MIAMI LAKES DATED OCTOBER 14, 2003, A COPY OF WHICH IS ATTACHED HERETO AS EXHIBIT A; PROVIDING FOR INSTRUCTIONS TO THE CITY CLERK; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, commencing October 1, 2004, the City of Miami Gardens will assume all of the public work activities that Miami-Dade County previously performed on behalf of the City, and

WHEREAS, the proposed Fiscal Year 04-05 budget provides for the required personnel and equipment in order for the City to take over the public works responsibilities, and

WHEREAS, the City will not be fully operational on October 1, 2004, and

WHEREAS, the City Manager recommends that the City utilize a contractor for a limited period of six (6) months to assist the City with necessary functions including pothole repair, catch basin maintenance, and other minor maintenance issues, and

WHEREAS, the City Manager also recommends that the City piggyback on an agreement between Salman Maintenance Service, Inc. d/b/a U.S. Lawns of South Dade and the Town of Miami Lakes, dated October 14, 2003,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, as follows:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORITY: The City Manager and City Clerk are hereby

authorized and directed to execute and attest, respectively, that certain contract with Salman Maintenance Service, Inc. d/b/a U.S. Lawns of South Dade for miscellaneous public works services, a copy of which is attached hereto as **Exhibit A**, by piggybacking on that certain agreement between Salman Maintenance Service, Inc. d/b/a U.S. Lawns of South Dade and the Town of Miami Lakes.

Section 3. INSTRUCTIONS TO THE CITY CLERK: The City Clerk is hereby authorized to obtain three (3) fully executed copies of the subject Agreement, with one to be maintained by the City; with one to be delivered to Salman Maintenance Service, Inc. d/b/a U.S. Lawns of South Dade, and with one to be directed to the Office of City Attorney.

Section 4. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
