

RESOLUTION No. 2004-108-159

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE AND ATTEST, RESPECTIVELY, THAT CERTAIN ADDENDUM TO THE AGREEMENT FOR PUBLIC WORKS BETWEEN THE CITY OF MIAMI GARDENS, FLORIDA AND THE FLORIDA DEPARTMENT OF CORRECTIONS TO AMEND THE COST FROM \$40,000.00 PER YEAR TO \$51,273.95, A COPY OF WHICH IS ATTACHED HERETO AS EXHIBIT A; PROVIDING FOR INSTRUCTIONS TO THE CITY CLERK; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on August 11, 2004, the City of Miami Gardens ("CITY") adopted Resolution No. 2004-98-149, which approved an Agreement with the Florida Department of Corrections ("FDC") whereby the FDC agreed to operate a program with minimum custody inmates to provide services to the CITY such as trash pick-up, landscaping, painting and other similar tasks, and

WHEREAS, pursuant to Resolution No. 2004-98-149, the CITY agreed to pay the sum of \$40,000.00 to FDC to cover the costs and salary of a correctional officer to supervise the inmates, and

WHEREAS, FDC has recently contacted the CITY and informed the CITY that due to its omission, it provided the CITY with an incorrect cost for the Agreement and, in fact, the cost should be \$51,273.95 not \$40,000.00, and

WHEREAS, the City Council wishes to approve an increase to the original cost of the Agreement,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, as follows:


Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORITY: The Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, that certain Addendum to the Agreement for Public Works between the City of Miami Gardens, Florida and the Florida Department of Corrections to amend the cost from \$40,000.00 per year to \$51,273.95, a copy of which is attached hereto as **Exhibit A**.



INSTRUCTIONS TO THE CITY CLERK: The City Clerk is hereby authorized to obtain three (3) fully executed copies of the subject Agreement, with one to be maintained by the City; with one to be delivered to the Florida Department of Corrections, and with one to be directed to the Office of City Attorney.

Section 4. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
