

RESOLUTION NO. 2004-95-146

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A GRANT APPLICATION WITH THE STATE OF FLORIDA, DEPARTMENT OF AGRICULTURE AND CONSUMER SERVICES, DIVISION OF FORESTRY; AUTHORIZING THE CITY MANAGER TO TAKE ANY AND ALL ACTIONS IN FURTHERANCE OF APPLYING FOR THE GRANT AND ACCEPTING THE SAME; PROVIDING FOR A MATCH FROM THE CITY FOR ALL GRANT FUNDS RECEIVED; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the State of Florida, Department of Agriculture and Consumer Services, Division of Forestry ("State of Florida") provides grants to municipalities for agricultural and forestry purposes, and

WHEREAS, the City Manager recommends that the City apply for a grant from the State of Florida in the amount of Fifty Thousand (\$50,000.00) Dollars to be used for equipment and/or trees, and

WHEREAS, the grant requires a one hundred (100%) percent match from the City in the event the grant funds are awarded, and

WHEREAS, the City Council would like to authorize the City Manager to apply for a grant from the State of Florida for the stated purposes,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


Section 2. AUTHORIZATION: The City Manager is hereby authorized to apply for a grant from the State of Florida, Department of Agriculture and Consumer Services, Division of Forestry, in the amount of Fifty Thousand (\$50,000.00) Dollars, and to take any and all actions in furtherance of applying for the grant and accepting the same. In addition, the City Council authorizes a one hundred (100%) percent match from the City of Miami Gardens, Florida for all grant sums awarded.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
