

RESOLUTION No. 2005-122-299

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE ACCEPTANCE OF A \$150,000.00 GRANT BY THE MIAMI-DADE COUNTY LANDSCAPE COMMITTEE TO LANDSCAPE ALONG NORTHWEST 2ND AVENUE (US 441) FROM 179TH STREET TO I-95 AND THE 7TH AVENUE EXTENSION, AUTHORIZING A MATCH OF FUNDS, AND AUTHORIZING THE CITY MANAGER TO TAKE ANY AND ALL STEPS NECESSARY TO EFFECTUATE THE RECEIPT OF THE GRANT FUNDS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Miami Gardens has been awarded a \$150,000.00 grant ("Grant") by the Miami-Dade County Landscape Committee for the purpose of landscaping along Northwest 2nd Avenue (US 441) from 179th Street to I-95, and the 7th Avenue extension, and

WHEREAS, the purpose of the Grant is for the design and construction of landscape, and

WHEREAS, the City Council would like to authorize the acceptance of the Grant, would further like to authorize a match of funds in the amount of \$150,000.00, and

WHEREAS, the City's match will come from the Public Works budget, and

WHEREAS, the City Council would like to further authorize the City Manager to take any and all steps necessary to effectuate the receipt of the Grant funds,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas

paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. ACCEPTANCE: The City Council for the City of Miami Gardens hereby accepts the \$150,000.00 Grant issued by the Miami-Dade County Landscape Committee for the purpose of landscape along Northwest 2nd Avenue (US 441) from 179th Street to I-95, and the 7th Avenue extension.

Section 3. AUTHORIZATION: The City Council for the City of Miami Gardens hereby authorizes a \$150,000.00 match of the Grant funds awarded by Miami-Dade County Landscape Committee. The City Council further authorizes the City Manager to take any and all steps necessary to effectuate the receipt of the Grant funds.

Section 4. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
