

RESOLUTION No. 2005-150-327

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A PURCHASE ORDER TO BEA INTERNATIONAL IN THE AMOUNT OF FIFTY-TWO THOUSAND FIVE HUNDRED (\$52,500.00) DOLLARS FOR ARCHITECTURAL SERVICES RELATING TO THE LANDSCAPING ON MIAMI GARDENS DRIVE FROM NORTHWEST 47<sup>TH</sup> PLACE TO NORTHWEST 2<sup>ND</sup> AVENUE; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on March 23, 2005 the City Council of the City of Miami Gardens awarded non-exclusive contracts for professional architectural, engineering and planning services, and

WHEREAS, BEA INTERNATIONAL ("BEA") was awarded a contract for landscape architectural services, and

WHEREAS, City staff requested that BEA provide a scope and cost to develop and prepare landscape and irrigation plans for the mediums, frontage roads, and right-of-way areas for Miami Gardens Drive from Northwest 47th Place to Northwest 2nd Avenue, and

WHEREAS, the cost of the proposal is estimated at Fifty-Two Thousand Five Hundred (\$52,500.00) Dollars, and

WHEREAS, the funding for the project is available in the transportation budget, and

WHEREAS, the City Council would like to authorize the City Manager to issue a purchase order to BEA in accordance with the proposal attached hereto as Exhibit "A",

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas

paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution

Section 2. AUTHORIZATION: The City Manager of the City of Miami Gardens is hereby authorized to issue a purchase order to BEA International in the amount of Fifty-Two Thousand Five Hundred (\$52,500.00) Dollars in accordance with the proposal attached hereto as Exhibit "A".

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
