

RESOLUTION No. 2005-28-205

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, ESTABLISHING AN ADOPT-A-ROAD PROGRAM IN THE CITY OF MIAMI GARDENS IN ACCORDANCE WITH THE GUIDELINES ATTACHED HERETO AS COMPOSITE EXHIBIT "A"; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Miami Gardens would like to encourage local businesses and organizations to assist the City in enhancing the appearance of the community and beautifying the City's roadways, and

WHEREAS, the City Manager has proposed an Adopt-A-Road Program for the City of Miami Gardens whereby individuals and organizations will be permitted to contribute to the beautification of Miami Gardens by scheduling clean-up events on certain roads throughout the City, and

WHEREAS, participants in the Adopt-A-Road Program will be able to have a sign erected on the roadways showing that a particular roadway has been "adopted,"

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


