

RESOLUTION No. 2005-49-226

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A NON-EXCLUSIVE CONTRACT WITH THE CORRADINO GROUP FOR TRAFFIC/TRANSPORTATION ENGINEERING, IN SUBSTANTIAL FORM AS THAT AGREEMENT ATTACHED HERETO AS EXHIBIT "A"; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has several projects that require professional consultants to provide services for traffic\transportation engineering services, and

WHEREAS, the City staff prepared a Request for Proposal in accordance with the Florida Consultant Competitive Negotiation Act, and

WHEREAS, Proposal Document No. 04-05-003 was advertised on November 26, 2004, and

WHEREAS, numerous proposals were received in response to the Request For Proposal, and

WHEREAS, the firm of the Corradino Group is capable of providing traffic\transportation engineering services to the City, and

WHEREAS, the City staff recommends that the City Council authorize an agreement with the Corradino Group for the traffic\transportation engineering services,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


