

RESOLUTION No. 2005-76-253

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, DONATING APPROXIMATELY 40 BUS BENCHES TO THE NORTH DADE MIDDLE SCHOOL FOR USE AT BOTH THE NORTH DADE MIDDLE SCHOOL AND THE INTERNATIONAL EDUCATION MAGNET; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Eunis J. Davis, the Principal of the North Dade Middle School has requested that the City of Miami Gardens donate approximately 40 bus benches for use at the North Dade Middle School and the International Education Magnet ("NDMS"), and

WHEREAS, the City Manager has determined that the bus benches have no commercial value, and

WHEREAS, pursuant to '274.06, Florida Statutes, a municipality is permitted to donate, destroy, or abandon any property that has no commercial value, in any way that the municipality deems fit, and

WHEREAS, the City Council for the City of Miami Gardens would like to donate the requested benches to NDMS for use at the school,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. DETERMINATION OF SURPLUS/AUTHORIZATION: The City Council of the City of Miami Gardens hereby deems the bus benches herein described as surplus property with no commercial value; and further authorize the City Manager to


donate the benches to the North Dade Middle School for use at both the North Dade Middle School and the International Education Magnet.
