

RESOLUTION No. 2006-30-376

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A PURCHASE ORDER TO KIMLEY-HORN AND ASSOCIATES, INC. IN THE AMOUNT OF SEVENTY THOUSAND (\$70,000.00) DOLLARS FOR PREPARATION OF A STATE ROAD 7 CORRIDOR STUDY AND REPORT; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS, PROVIDING AN EFFECTIVE DATE

WHEREAS, on March 23, 2005, the City Council for the City of Miami Gardens awarded a non-exclusive continuing Contract for professional/architectural, engineering and planning services with Kimley-Horn and Associates, Inc. ("Kimley-Horn"), and

WHEREAS, City staff has requested that Kimley-Horn provide a scope and cost to develop a State Road 7 Corridor Study and Report in accordance with the Contract, and

WHEREAS, it is estimated that the cost for completion of the Study and Report is Seventy Thousand (\$70,000.00) Dollars, and

WHEREAS, funding for this project is available from the FDOT Livable Communities Program funding which was approved by the City Council on May 11, 2005,

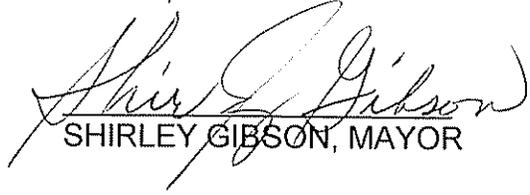
NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Manager for the City of Miami Gardens is hereby authorized to issue a Purchase Order to Kimley-Horn and Associates, Inc. in the amount of Seventy Thousand (\$70,000.00) Dollars for completion of State Road 7 Corridor Study and Report.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
