

RESOLUTION No. 2006-36-382

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, CONFIRMING APPOINTEES TO THE DR. MARTIN LUTHER KING, JR. HOLIDAY STEERING COMMITTEE; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on February 11, 2004, the City Council of the City of Miami Gardens adopted Resolution No. 2004-29-80, establishing a Dr. Martin Luther King, Jr. Holiday Steering Committee to organize the events for an annual holiday celebration, and

WHEREAS, the Mayor and each member of the City Council is permitted to nominate a member to the Committee, and

WHEREAS, Mayor Shirley Gibson previously appointed Laura Rzeszotski, but Ms. Rzeszotski has not been able to serve; Councilwoman Barbara Watson previously appointed Sandra Rivers, however, Ms. Sandra Rivers has also been unable to serve; Councilwoman Audrey King appointed Joyce McClain to serve as her appointee, and

WHEREAS, Mayor Shirley Gibson would like to appoint Dr. Sallie Holmes as her representative; Councilwoman Barbara Watson would like to appoint Inez Rowe; and Councilman Ulysses Harvard would like to reconfirm the appointment of Joyce McClain, as his appointee to the Committee,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

City of Miami Gardens hereby confirms the following appointments to the Martin Luther King, Jr. Steering Committee:




Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
