

RESOLUTION No. 2006-39-385

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, CONFIRMING THE APPOINTMENT OF IRVIN LYONS, JR. AND JOE BRADWELL TO THE ELDERLY AFFAIRS ADVISORY COMMITTEE; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Miami Gardens has adopted an Ordinance creating an Elderly Affairs Advisory Committee ("Committee"), and

WHEREAS, pursuant to that Ordinance, the Mayor and each member of the City Council have the right to appoint a member to the Committee, and

WHEREAS, each member appointed by the Mayor and City Councilmember serves at the pleasure of the Mayor or City Councilmember appointing such person, and

WHEREAS, the terms of all committee members coincide with the terms of the Mayor or City Councilmember making the appointment, and

WHEREAS, previously, other members of the City Council have made their appointments to the Committee, and

WHEREAS, the Mayor would like to name Joe Bradwell as her appointee to the Committee, while Vice Mayor Braynon would like to name Irvin Lyons, Jr. as his appointee to the Committee,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS. The foregoing Whereas

paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. APPOINTMENT: The City Council for the City of Miami Gardens hereby confirms Vice Mayor Braynon's appointment of Irvin Lyons, Jr. to the Elderly Affairs Advisory Committee and also confirms the Mayor's appointment of Joe Bradwell to the Committee.

Section 3. EFFECTIVE DATE. This Resolution shall take effect immediately upon its final passage.
