

RESOLUTION No. 2006-83-429

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, ADOPTING THE CITY OF MIAMI GARDENS 2006-2011 HUD CONSOLIDATED PLAN AND 2006-2007 ACTION PLAN, ATTACHED HERETO AS EXHIBIT "A"; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in January of 2006, the City of Miami Gardens was granted entitlement status from the U.S. Department of Housing and Urban Development (HUD), and

WHEREAS, the City was awarded \$1.4 M in Community Development Block Grant (CDBG) funds for the 2006/2007 program year, and

WHEREAS, as an entitlement jurisdiction, the City will be able to administer a CDBG Program and direct the use of the annual allocation, and

WHEREAS, in order to establish a CDBG Program and receive the above-mentioned allocation, the City is required to submit a 5-year Consolidated Plan which describes the long term goals of the program and a 2006-2007 Action Plan, which provides specific goals and activities for the first program year, and

WHEREAS, in accordance with HUD regulations, City staff prepared a draft 5-year Consolidated Plan and 2006-2007 Action Plan and made them available for public review and comment for thirty (30) days commencing on Thursday, June 15, 2006, and ending on Friday, July 14, 2006, and

WHEREAS, in addition to the public comment period, the City held two (2) public hearings regarding the Annual Action Plan activities and the Consolidated Plan document, and

WHEREAS, the City Council of the City of Miami Gardens, Florida, desires to adopt the City of Miami Gardens 2006 – 2011 HUD Consolidated Plan and 2006 – 2007 Action Plan,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORITY: The Mayor and members of the City Council hereby adopt the City of Miami Gardens 2006 – 2011 HUD Consolidated Plan and 2006-2007 Action Plan, attached hereto as Exhibit "A" and incorporated by reference.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
