A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A PURCHASE ORDER IN THE AMOUNT OF \$61,739.50 TO DELL COMPUTERS FOR THE PURCHASE OF PERSONAL COMPUTERS, COMPUTER UPGRADES, LAPTOPS, ETC., BY RELYING UPON THAT CERTAIN STATE OF FLORIDA BID #250-000-03-1; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is necessary for the City to purchase laptops and personal computers for Police Department use, and

WHEREAS, City staff is requesting that the City Council authorize the purchase of personal computers, computer upgrades, laptops, etc., for the Police Department from Dell Computers for this purpose, and

WHEREAS, the State of Florida competitively bid for computer hardware and awarded the bid to several companies, and

WHEREAS, Dell Computers was one of the companies selected by the State, and

WHEREAS, City staff is recommending that the City Council rely upon State of Florida bid #250-000-03-1 for the purchase of computers for the Police Department,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Council of the City of Miami Gardens hereby authorizes the City Manager to issue a purchase order in the amount of

\$61,739.50 to Dell Computers for the purchase of personal computers, computer upgrades, laptops, etc., for the Police Department by relying upon that certain State of Florida Bid #250-000-03-1.

Staff Summary

As the City of Miami Gardens Police Department continues to grow and add staff, the purchase of additional equipment for everyday functions is imperative. The addition of eleven new police officers positions has been authorized for FY 08/09; therefore the purchase of additional computer equipment to outfit those officers must be made.

The proposed computer purchase includes (List some of the items being purchased i.e. laptops, servers, etc.)

These items are new requests for the sole purpose of addressing technological demands and implementation in the police department. The equipment will be deployed as soon as it is received and will be utilized to augment current resources. Additionally, some of the software items requested will be used to upgrade existing systems to enhance performance and service to the community. The funds for this purchase are being provided by police impact fees and FY 08 equipment bond funding. The total purchase is \$61,739.50.

The State of Florida competitively bid for information technology hardware and awarded to several companies. Dell is one of the companies awarded. Historically, the City has always purchased its personal computers from Dell in accordance with the State of Florida bid 250-000-03-1. (See attached quotations)

Recommendation

That the City Council approve the attached resolution authorizing the City Manager to issue a purchase order to Dell Computers for the purchase of personnel computers, computer upgrades, laptops, etc. needed for the Police Department in the total of \$61,739.50.
