

RESOLUTION No. 2008-11-698

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING A CHANGE ORDER TO THAT CERTAIN AGREEMENT BETWEEN THE CITY OF MIAMI GARDENS AND CRAVEN THOMPSON & ASSOCIATES, INC., FOR ENGINEERING SERVICES IN CONNECTION WITH THE CITY'S LIVABLE NEIGHBORHOOD INITIATIVE PROGRAM, IN THE AMOUNT OF \$64,500. PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has established a Livable Neighborhood Initiative Program, to provide funding from Community Development Block Grant funds for infrastructure improvements, and

WHEREAS, on May 23, 2007, City Council awarded a Contract to Craven Thompson & Associates, Inc. (CTA) to conduct a Basis of Design Report as part of the City's Livable Neighborhoods Initiative, and

WHEREAS, in the course of proceeding with the approved work, it was determined by City staff that additional information was needed in order to complete this first phase of the Livable Neighborhoods Initiative, including the provision of sketch and legal descriptions for the common areas (roadways) of each of the three (3) communities within the scope of this project,

WHEREAS, in addition it has become necessary to provide for off-duty police protection for the CTA field survey crew, and

WHEREAS, as a result of the above, the cost of the Contract to CTA has increased by \$64,500,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, as follows:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.



AUTHORITY: The City manager is hereby authorized to issue a Change Order to that certain Agreement between the City of Miami Gardens and Craven Thompson & Associates, Inc., for engineering services in connection with the City's Livable Neighborhood Initiative Program, in the amount of \$64,500.00.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
