

RESOLUTION No. 2008-12-699

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A CHANGE ORDER TO PURCHASE ORDER 08-00326, WHICH WAS ISSUED TO ELAN LAWN AND LANDSCAPING SERVICES, INC., FOR TREE REMOVAL SERVICES, INC., FOR AN ADDITIONAL AMOUNT OF \$28,500; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE

WHEREAS, on November 28, 2005, the City Manager awarded Elan Tree Service, LLC, located in Pembroke Pines, Florida a term contract for tree removal and pruning services on an as-needed basis, and

WHEREAS, on November 14, 2007, the City Council also approved an authorization to issue a purchase order in the amount of \$111,270 for tree removal services, and

WHEREAS, in order to begin capital improvements at Rolling Oaks Park, city staff intends to remove existing trees in direct vicinity of the proposed construction project(s), and

WHEREAS, upon issuance of permit 2007-TREE-PER-00585 from the Department of Environmental Resources Management dated December 21, 2007, it required protective barriers (fencing) be constructed in order to avoid disturbance to any remaining trees within the proposed construction area, and

WHEREAS, the tree protection services requirement by DERM was unknown to the City at that time of issuing the purchase order, and a change order that would include tree protection services for an additional \$28,500 is required,


NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


Section 2. AUTHORIZATION: The City Council of the City of Miami Gardens hereby authorizes the City Manager to issue a change order to Purchase Order 08-00326, which was issued to Elan Lawn and Landscaping Services, Inc., for tree removal services, for an additional amount of \$28,500.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
