WHEREAS, on May 12, 2007, City staff advertised RFP # 07-08-028 for the purchase of 14 marked Ford Crown Victorias with equipment, 1 Ford Explorer with equipment and 2 Chevrolet Impalas with equipment for use by the Police Department, and

WHEREAS, four bids were received and publicly read, and

WHEREAS, due to that fact, staff has found that it is more cost effective to purchase Chevrolet Impalas in accordance with a State of Florida Sheriff's Bid, staff is requesting that the City Council reject all bids for this purpose,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:



## Title

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, REJECTING ALL BIDS RECEIVED IN RESPONSE TO RFP # **07-08-028** FOR CHEVROLET IMPALAS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

## Staff Summary

The City Council authorized financing in the amount of \$4.7 million for the purchase of additional vehicles and equipment on November 14, 2007, in order to enhance police and general citywide operations.

## Analysis

As the Miami Gardens Police Department continues to expand, the need for additional vehicles and equipment is imperative. The Department has been authorized to increase staffing for FY 08/09 by eleven police officers. As such specifications were prepared by staff for the purchase of 14 marked Ford Crown Victorias with equipment, 1 Ford Explorer with equipment and 2 unmarked Chevrolet Impalas with equipment and advertised on May 12, 2008. A broadcast notice was sent to 154 vendors. Twenty-two vendors requested bid packages. The bids were opened on May 29, 2008. Four bids were received and publicly read. A copy of the bid document and submittals are available at the assistant to the mayor and council's office for review. The tabulation sheet is attached as Exhibit "A".

The proposals of the apparent low bidders were evaluated for compliance with the specifications. Funding for this project is available from the equipment bond.

Since the time of the issuance of the vehicle bid, the Miami Gardens Police Department will assume Specialized Service Investigations, the need for additional officers and vehicles are imperative. A total of fifteen vehicles are required in stead of just two Chevrolet Impala. The specialized service investigations unit will not require all of the equipment specified in the City's bid due to that fact, staff has found that it is more cost effective to purchase in accordance with the Sheriff's Bid. Staff estimates that purchasing in accordance with the Sheriff's bid will save approximately \$105,000.

**RECOMMENDATION:**

It is recommended that City Council approve the attached resolution authorizing the rejection of the award for the two Chevrolet Impalas to Maroone Chevrolet, located in Pembroke Pines, Florida.
