

RESOLUTION No. 2008-133-820

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A PURCHASE ORDER TO DON REID FORD, IN THE AMOUNT OF \$445,629.00 FOR THE PURCHASE OF VEHICLES, PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council authorized financing in the amount of \$4.7 million for the purchase of additional vehicles and equipment on November 14, 2007, in order to enhance police and general citywide operations, and

WHEREAS, twelve (12) new police officer will join the Police Department in Fiscal Year 2008/2009, and

WHEREAS, it is incumbent upon the City to provide vehicles for these officers, and

WHEREAS, City staff prepared specifications for the purchase of 14 marked Ford Crown Victoria's with equipment and 1 Ford Explorer with equipment, and

WHEREAS, the bid was and advertised on May 12, 2008, and four bids were received in response, and

WHEREAS, Don Reid Ford, located in Maitland, Florida was the low bidder on the Ford vehicles, and

WHEREAS, City staff is recommending that the City award a bid to Don Reid Ford in the amount of \$445,629.00 for the purchase of the vehicles and the extended warranties,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.



Staff Summary

The City Council authorized financing in the amount of \$4.7 million for the purchase of additional vehicles and equipment on November 14, 2007, in order to enhance police and general citywide operations.

Analysis

As the Miami Gardens Police Department continues to expand, the need for additional vehicles and equipment is imperative. The Department has been authorized to increase staffing for FY 08/09 by twelve police officers. As such specifications were prepared by staff for the purchase of 14 marked Ford Crown Victorias with equipment, 1 Ford Explorer with equipment and 2 unmarked Chevrolet Impalas with equipment and advertised on May 12, 2008. A broadcast notice was sent to 154 vendors. Twenty-two vendors requested bid packages. The bids were opened on May 29, 2008. Four bids were received and publicly read. A copy of the bid document and submittals are

available at the assistant to the mayor and council's office for review. The tabulation sheet is attached as Exhibit "A".

The proposals of the apparent low bidders were evaluated for compliance with the specifications. Funding for this project is available from the equipment bond.

RECOMMENDATION:

It is recommended that City Council approve the attached resolution authorizing the issuance of a purchase order to Don Reid Ford, located in Maitland, Florida in an amount of \$418,138.00 for the purchase of fourteen 2009 Ford Crown Victorias and \$27,491.00 for the purchase of one 2009 Ford Explorer for the total amount of \$445,629.00 which includes the extended warranties.
