A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, RATIFYING COUNCILMAN MELVIN BRATTON'S APPOINTMENT OF ROBERT DAISE, FANNIE M. WHEREAS, the City has established a Citizens Advisory Committee ("CAC") to among other things, serve as a liaison between the city and the public as it relates to issues of great public importance involving the Police Department, and to dispense accurate information regarding issues of great public importance involving the Police Department, and

WHEREAS, the Mayor and each member of the City Council is to appoint three members to the CAC for two (2), three (3), and four (4) year terms respectively, and

WHEREAS, Councilman Melvin Bratton has appointed, Robert Daise (Clergy), Fannie M. Howell (Citizen), and Patricia Lightfoot (Citizen) to the CAC for a term of two (2), three (3), and four (4) years, respectively, and

WHEREAS, it is appropriate for the City Council to ratify Councilman Melvin Bratton's appointments,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:


