A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, PROVIDING A SPONSORSHIP IN THE AMOUNT OF \$5,000.00 TO WORLDCARE, INC., IN SUPPORT OF A CELEBRITY GOLF TOURNAMENT & BANQUET; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, WorldCare is a nonprofit 501(C)(3) organization whose mission is to assist victims of hurricanes and to provide support in the City of Miami Gardens to victims of hurricanes, and

WHEREAS, WorldCare is hosting a Celebrity Golf Tournament & Banquet on May 9th, 2008 at the County Club of Miami Lakes, Florida, and

WHEREAS, a portion of the proceeds of the Celebrity Golf Tournament & Banquet will assist residents of Miami Gardens who have been and may be victims of hurricanes, and

WHEREAS, on April 23, 2008, the City Council voted and authorized the City Manager to expend the sum of \$5,000 for a City sponsorship of the event,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. SPONSORSHIP: The City Council of the City of Miami Gardens hereby agrees to provide a sponsorship in the amount of \$5,000.00 to Worldcare, Inc., in support of the Celebrity Golf Tournament & Banquet to be held at the County Club of Miami Lakes, Florida.

Section 3. NUNC PRO TUNC EFFECT: This resolution shall be deemed effective as of April 23, 2008.

Section 4. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, PROVIDING A SPONSORSHIP IN THE AMOUNT OF \$5,000.00 TO WORLDCARE, INC., IN SUPPORT OF A CELEBRITY GOLF TOURNAMENT & BANQUET; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

Staff Summary

The City participates as a member of WorldCare Inc., which serves the community by providing assistance to the victims of natural disasters, including but not limited to hurricanes. Members of Worldcare include local government, civic, business, faith, municipal and other agencies in both Miami Dade and Broward counties. The primary funding source of this non-profit organization is donations and fundraising events. Worldcare scheduled a golf tournament on May 9th, 2008 for fund raising and desires the City's participation. At the April 23rd, 2008 meeting, Council agreed to support this event and directed staff to return with an appropriate Resolution.

I recommend that the Council approve the attached Resolution, supporting the City's \$5,000 sponsorship of the golf tournament held by Worldcare on May 9th, 2008.
