Dear Business and Property Owners:

Thank you for your interest in the Miami Gardens Police Department’s SafeCam Program. The program is designed to provide police the ability to access your private security cameras that view public areas for the purpose of observing, interdicting and obtaining documentation of illegal activity. If you are interested in signing up for the Program, please fill out the attached application form and email it to [safecam@mgsdfl.org](mailto:safecam@mgsdfl.org) or deliver it to the Miami Gardens Police Department located at 18611 NW 27<sup>th</sup> Ave, Miami Gardens, FL 33056.

Here is a summary of the SafeCam Program:

- The Program is completely voluntary. Property and business owners enroll at their option and can withdraw their participation at any time.
- The Miami Gardens Police Department obtains access to the security cameras through a dedicated URL address provided by the business and/or property owners.
- Only cameras with views of public areas will be accessed by the Miami Gardens Police Department.
- The Miami Gardens Police Department may obtain a recording of observed criminal activity shown via the cameras. The cameras will only be used for real-time viewing and obtaining documentation of crimes that have occurred.
- Activity in public areas will be monitored by the Miami Gardens Police Department through the private cameras as dictated by investigative needs. Participation in the SafeCam program does not imply that all cameras will be continuously monitored.
- Participation in the SafeCam Program will be billed annually at a cost of \$25.00 per month.
- No fee will be paid by the Miami Gardens Police Department for access to the private cameras.
- Under no circumstances shall owner construe they are acting as an agent and/or employee of the Miami Gardens Police Department through the SafeCam Program.

The Miami Gardens Police Department looks forward to working with the community through this Program. Through your participation in this Program, the Miami Gardens Police Department hopes to enhance the security and enjoyment of public areas within the City of Miami Gardens.
